In this first edition, we highlight **the recent reforms of sexual criminal law in Spain (2022 and 2023) and Switzerland (2024)**. Both countries have undertaken profound revisions to better protect victims of sexual violence and to meet the requirements of the 2011 Istanbul Convention. **Thierry Godel, Morgane Délèze, and Alicia Rodríguez Sánchez** comment on these new legislations, which introduce major changes regarding sexual abuse and assault, as well as the criminalization of behaviors such as stealthing and revenge porn.

Additionally, **Camille Perrier Depeursinge** and **Carlos Fuertes Iglesias** provide their expert insights on the different legislative approaches adopted by Switzerland and Spain. Finally, in her academic work, **Léonore Lebedeva** sheds light on the implications of the redefinition of consent in the new Swiss criminal law on sexual matters.

Don't miss the insightful chronicles by José Hurtado Pozo on criminal dogmatics and the theory of objective imputation. Three of his works are available in open access on our website.

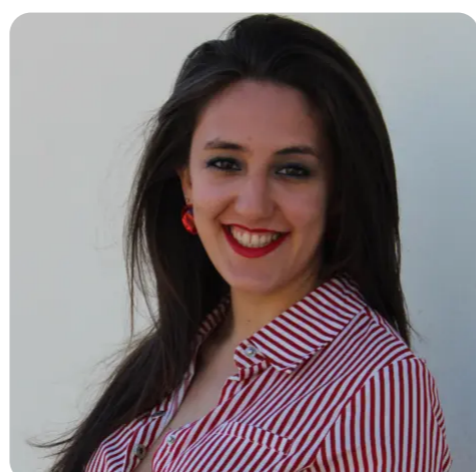

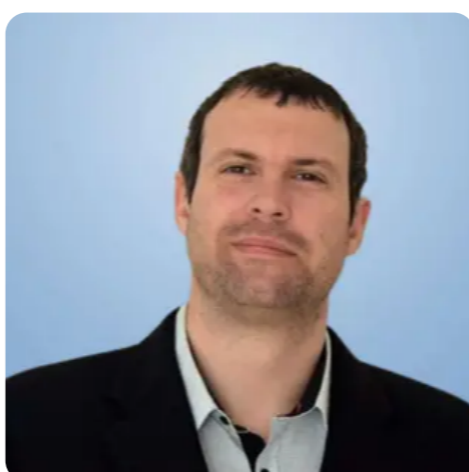
